Should this occur, you will be required to pick up the item(s) WITHIN 10 DAYS OR THE ITEM(S) WILL BECOME THE PROPERTY OF FAIRY TALE GOWNS.

If you wish to have an item(s) back which has not sold, you must call us and schedule an appointment to pick up the item(s) WITHIN 10 DAYS BEFORE THE END OF THE CONSIGNMENT PERIOD. If you do not pick up the item(s) as scheduled and do not notify us, the item(s) WILL BECOME THE PROPERTY OF FAIRY TALE GOWNS. If you and Fairy Tale Gowns mutually agree to re-consign an item(s), you must authorize the extension by calling us at 828-606-2221 BEFORE the end of the original consignment period. PLEASE NOTE THAT IT IS YOUR RESPONSIBILITY TO NOTIFY US SHOULD YOUR ADDRESS, EMAIL OR CONTACT INFORMATION CHANGE.

You will receive 50% of the final selling price of your item(s). Should an item require cleaning or repair, you hereby authorize Fairy Tale Gowns to do so and you will receive 40% of the final selling price. The ultimate selling price is solely at the discretion of Fairy Tale Gowns. You will be notified when an item sells and checks will be available on the 10<sup>th</sup> of the month following the month of sale.

We take extreme care in safeguarding your item(s); however, we do not provide insurance for consigned items and will not be held responsible for damage, including damage from cleaning, theft, loss or natural disaster.

By signing this agreement, you are acknowledging that (1) this agreement constitutes the entire agreement between you and Fairy Tale Gowns; (2) you fully understand the terms of the agreement; (3) the items being consigned are not stolen; and (4) you are in fact the owner of the item(s) being consigned and all items are free of any encumbrances or liens.
